8am – 9am

- (1) Lecture credit - Operations – Disaster Planning MCI

In this class we will cover the Tri-county Emergency Control Authority (MCI) protocol MCI 1-11. Students will play an active role and will determine who is going to be in charge of training sectors in the afternoon training exercise.

9am-11am

- (2) Lecture credit – Operations- Triage

In this class students will identify what a multiple causality incident is and what are some of the potential MCI incidents that would affect our local resources. Students will review the START system primary and secondary survey. The information reviewed in this class will be very helpful in the afternoon practical session. (You must attend this session to get the credits for the afternoon Triage session).

11am-Noon

(1)Lecture – Operations- EMS Systems Operations credit for lunch (Lunch) I would like to have a passing dish lunch. Everyone bring a passing dish / desert and we have a work lunch. We will break for 10 minutes to get food and for the remaining 50 minutes we will cover the SAESA.org web site and the features offered that will help you know how many c.e credits you have.
